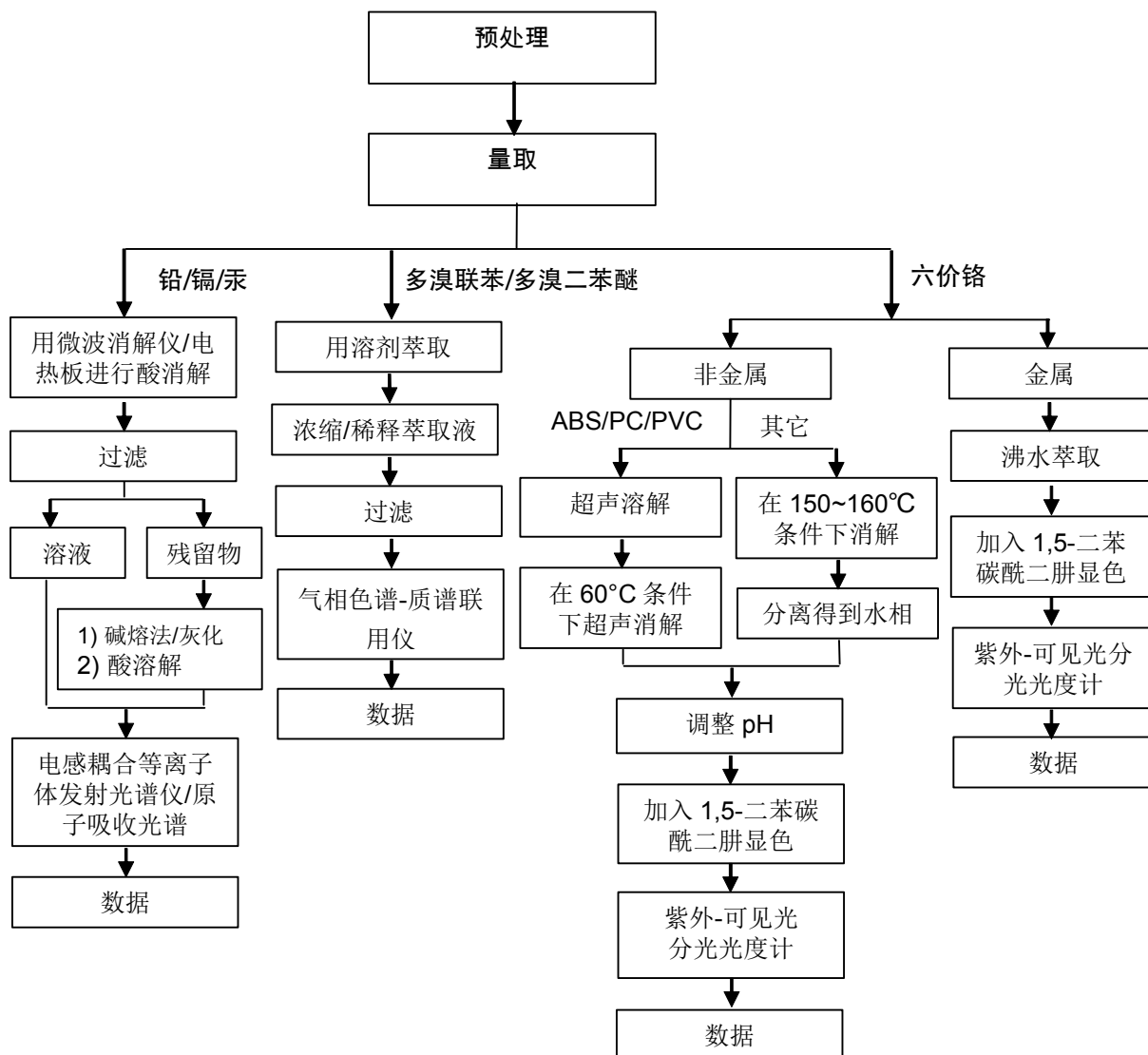

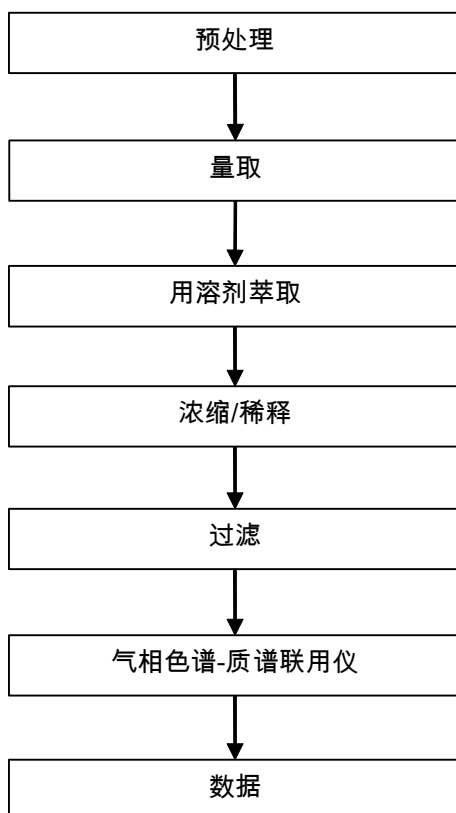
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs测试流程图
